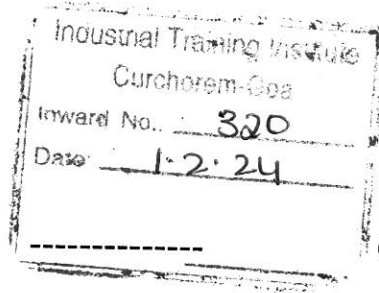

The term of reference shall be as per attached Annexure also specifying therein indicators for monitoring the performance of the IMC.


The term of office of the IMC shall be three years from the date of issue of this notification or till the reconstitution of the IMC thereafter. The members representing the industries may change by name and number depending upon the necessity of the IMC from time-to-time under specific orders of the Government. Change in the official members if any, shall be on the basis of the recommendations of the Department of Skill Development & Entrepreneurship.

The IMC shall meet as frequently as required and in any case at least once in three months. The members will have to intimate to the Chairman about his/her inability to attend the meeting on genuine ground and obtain leave of absence. Any member remaining absent for three consecutive meetings without leave of absence shall cease to be member of the IMC from the date of the third absence.



The non-official members, who attend the meeting shall be paid a fixed honorarium of Rs. 1500/- per meeting and no other TA/DA shall be payable.
